ATTENDANCE:

The regular meeting of the Fenner Town Board was called to order at 8:04 PM by Supervisor Jones with the Pledge of Allegiance.

Councilperson Strack motioned to accept the March Town Board meeting minutes. Seconded by Councilperson Pushlar. Approved by the Board.

Councilperson Wester motioned to accept the Town Clerk's Monthly Report as presented Seconded by Councilperson Cody. Approved by the Board.

Councilperson Pushlar motioned to accept the Town Supervisor's Monthly Report as presented Seconded by Councilperson Strack. Approved by the Board.

The Highway Superintendent report was presented by Highway Superintendent and is available for review at the town offices.

NEW BUSINESS –

County is going to paint The Town of Fenner parking lot lines

County updates –

Supervisor update: The County proposed a resolution stating that in 2025 the county would be taking 3% of Madison county's Town and Villages tax money- that would affect the Town of Fenner by approximately \$15,000 loss. Said resolution was pulled by the county on 04/09/24.

Oxbox Hill Solar Farm/ has not sent a letter of intent to the Town of Fenner or Town of Fenner attorney at this time. The Town has had no correspondence with Oxbox Hill Solar in some time.

Old Business - none

Public Comments- – A few Town residents living on Irish Ridge Road brought concerns to the Town Board regarding the trees that were cut down, stating that they were old but functional. They felt a lot of changes have been made over the years, many positive, but in the last few years it has been getting aggressive and residents are concerned that cleared out ditches and cover could be compromising the roadsides. A resident was concerned that it was just wrong to take down that many trees, which goes against the comprehensive plan. Another resident stated the Highway department asked for permission from the landowners before removal, another resident was asking for more trees to be cut down from the other side of the road. Further, a resident mentioned trees might have looked sufficient but had big holes and a few had actually fallen on his house. Road salt, storms, erosion and wind has destroyed many of the trees. Safety was the biggest concern for all.

VOUCHERS:

Councilperson Pushlar moved to approve payment of the General Fund claims numbers G24 – 37 - G24-55 in the amount \$8,476.63 as set forth in abstract number 3 and as audited. Seconded by Councilperson Cody. Approved by the Board.

Councilperson Cody moved to approve payment of the Highway Fund claims numbers H24-33 - H24-41 in the amount \$40,366.98 as set forth in abstract number 3 and as audited. Seconded by Councilperson Strack. Approved by the Board, with the exception of voucher for culverts
